STALLION SERVICE INFORMATION

We are delighted that you have decided to include a Jud Little Ranch stallion in your 2019 breeding program and we look forward to having the opportunity to serve you. Please keep in mind that a stallion's book is filled on the basis of those booking fees received first. Returning the completed breeder's contract with your booking fee and a copy of your mare's papers will help ensure your place in the stallion's book for 2019.

A properly executed contract and a copy of the mare's registration papers must be on file before ordering semen. Please make every effort to order semen the DAY BEFORE you need shipment. Shipment requests will be filled in the order received. We must be notified before **9:00 a.m. Central Standard Time on the day of shipment**. We can ship semen ONLY on breeding days. 2019 collection dates will be sent to you with the final contract. To order semen, please contact the Ranch Office at 580-653-2384 or 580-221-4654.

The entire stallion fee and shipping charges must be paid prior to semen shipment. There will be a \$300 fee for each semen shipment sent via UPS or FedEx. This fee covers the cost of one collection and one shipment to you; return shipping fees are at your expense. We ask that you return the Equitainer promptly; excessive delay could result in a fee for rental charges. Failure to return the Equitainer will result in charges for the item. We accept checks, Visa or MasterCard payment. **Please note that all credit card payments will be charged a 3% bank fee.**

SEMEN WILL BE SHIPPED VIA UPS OR FEDEX; CORRECT PHYSICAL ADDRESS IS MANDATORY. WE WILL NOT BE RESPONSIBLE FOR UNDELIVERABLE SHIPMENTS. If requesting semen on a Friday, please be aware of whether or not your address offers UPS/FedEx priority overnight Saturday delivery. If not, please have an address ready where the shipment can be sent for Saturday pick-up. Counter-to-counter shipping via Southwest Airlines is available upon request, for an additional charge, if the request is made in a timely manner. Please be aware of the limited availability and late arrival hour of flights able to be met after stallion collection for the day. The Jud Little Ranch is not responsible for cancelled or delayed flights. If method of shipping is unknown prior to semen request, you may pay the UPS or FedEx fees and additional charges for counter-to-counter shipping by credit card on the day of request or they can be billed to you.

Please notify us if a pregnancy resulted from the shipment in order to be placed on the stallion's AQHA breeding report. Your mare will NOT be placed on the stallion breeder's report without confirmation of a pregnancy. Breeder's certificates will only be sent once you notify the ranch of a live foal. Procedures:

1. Complete a stallion service contract. This contract can be downloaded from our website, or you may request a copy to be mailed to you. Stallion brochures are also available upon request; contact the Ranch Office at 580-653-2384.
2. Mail a signed contract, a copy of your mare's papers and the \$500 booking fee to the ranch. Once approved, signed copies will be returned to you.
3. Submit the remainder of the stallion service fee (your stallion's fee minus \$500) and the shipping fee before requesting semen.
4. Breeding days are every other day; schedule will be provided with contract. Request semen the day before needed, if possible. Confirm the need for semen by 9 a.m. the day of shipment. Requests can be called into the Ranch Office at 580-653-2384. All fees must be paid before shipping.
5. Verify that the ranch has a correct shipping address for you. Shipments will be sent UPS or FedEx. If a tracking number is needed, please request that at time of semen request.
6. Return the Equitainer. Failure to return will result in charges.
7. Notify Ranch Office at 580-653-2384 when your mare's pregnancy is confirmed. You will NOT be placed on the stallion's breeding report if you do not confirm the pregnancy with us.
8. Notify the Ranch Office at 580-653-2384 next year when your foal is born. At this time, the breeders' certificate will be sent to you to register your foal. The form will NOT be sent until you confirm a live foal.

Jud Little Ranch Cooled Transported Semen Policy

BREEDING OF THE MARE BY COOLED TRANSPORTED SEMEN. The Mare Owner is responsible for all facets of breeding the Mare and agrees to comply with all related breed association requirements concerning the use and handling of cooled semen. The Mare Owner agrees to use his/her best efforts to perform the insemination procedure within 24 hours, but not more than 48 hours after collection of semen from the Stallion. The Mare Owner agrees that an individual who is qualified and experienced in the use and handling of cooled semen will perform the insemination. The Mare Owner agrees to use all cooled semen provided by this Agreement for the Mare named in this contract and no other. THE STALLION MANAGER MAKES NO WARRANTY OR GUARANTEE, EXPRESS OR IMPLIED, WITH RESPECT TO COOLED SEMEN, INCLUDING, WITHOUT LIMITATION, THE WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. THE STALLION MANAGER MAKES NO GUARANTEE OF DELIVERY WITHIN A CERTAIN TIME PERIOD AND MAKES NO GUARANTEE THAT THE COOLED SEMEN WILL SAFELY REACH THE INSEMINATION POINT WITHOUT LOSING INTEGRITY, QUALITY, OR CHARACTERISTICS. Jud Little Ranch reserves the right to ship frozen semen rather than cooled semen at its sole discretion.

EMBRYO TRANSFERS. If more than one embryo is produced from a Stallion breeding under this Agreement and if multiple embryos are transferred, then the Mare Owner must notify the Stallion Manager within 48 hours of transfer of the embryo(s). If embryo transfers result in multiple pregnancies, then the Mare Owner must pay the Stallion Manager the Stallion Service Fee for EACH pregnancy before ANY breeder's certificates will be issued.

LIVE FOAL GUARANTEE. If the mare fails to produce a live foal from the breeding privilege granted by this Agreement, the Mare Owner may rebreed the Mare (or a substitute mare mutually agreed upon by the Mare Owner and the Stallion Manager) during the SUBSEQUENT breeding season. If the breeding is not used in the subsequent breeding season, the Mare Owner forfeits the right to the breeding. The Mare Owner may not assign this breeding contract or substitute any other mare for the Mare under this Agreement without the prior written consent of the Stallion Manager. Any attempted assignment without the prior consent of the Stallion Manager, will, at the option of the Stallion Manager, terminate this Agreement and release the Stallion Manager from all obligations hereunder. "LIVE FOAL" means that the foal resulting from the breeding stands and nurses without assistance and lives for 24 hours. This return breeding privilege is conditioned upon the Mare Owner giving the Stallion Manager written notice within 7 days after foaling or aborting that the Mare did not produce a live foal. This notice must be accompanied by a certificate from the attending veterinarian that no live foal was born.

A "Breeder's Certificate" will be issued for the foal conceived by the mating when stallion fees and all other expenses have been paid in full. The Mare Owner will only receive a Breeder's Certificate when the Animal Records Manager has been notified that a live foal has been produced.

THE LIVE FOAL GUARANTEE IN THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE and should the Mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee granted shall be void. However, the Stallion Manager may, at his discretion, upon application and payment of a new booking fee, continue to honor the live foal guarantee granted to the original owner. In the event that the Stallion Manager agrees to the transfer of assignment of the "live foal guarantee" rights, under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof, insofar as the same may then be applicable.

ENTIRE AGREEMENT / GOVERNING LAW / VENUE. This Agreement contains the entire agreement between the parties and may be amended only in writing signed by each of the parties. Oklahoma law governs this Agreement, all of the terms and provisions of which are performable in Carter County, Oklahoma. UNDER OKLAHOMA LAW (76 OKL. ST. ANN. S 50.1) AN EQUINE OR LIVESTOCK ACTIVITY SPONSOR OR EQUINE OR LIVESTOCK PROFESSIONAL IS NOT LIABLE FOR THE DEATH OR INJURY TO A PARTICIPANT IN, OR SPECTATOR, OR BYSTANDER TO THE EQUINE OR LIVESTOCK ACTIVITY DUE TO THE INHERENT RISKS INVOLVED IN LIVESTOCK OR EQUINE ACTIVITIES.
